CONDITIONAL USE PERMIT 05-18 REVOCATION, 51 MAIN STREET.

SUMMARY

Gallaty Consulting Inc. was granted a Conditional Use Permit (CUP 05-18) and entered into a development agreement (DA 2018-02) to operate a commercial cannabis manufacturing and distribution operation at 51 Main Street. The Development Agreement stipulates a gross revenue fee of 2% on quarterly sales for the business as well as an annual area charge of \$1.50 per square foot of operable business space.

City received verbal confirmation from Mr. Gallaty that business operation had started on premises commencing at or before Q1 2020. Mr. Gallaty was given warning on multiple occasions that to stay within the bounds of CUP 05-18 and DA 2018-02, that the above mentioned fees would have to be paid to the City as well as all necessary fire and planning inspections of the premises completed.

At this time of writing, Gallaty Consulting Inc.'s required development agreement fees remain unpaid and no fire or planning inspection has been completed, both of which constitute a violation of CUP 05-18.

Staff is bringing the matter to Planning Commission for recommendation to City Council,

DISCUSSION

Condition of approval no. 3 attached to CUP 05-18 by Resolution 04-19, reads as follows:

"3. The applicant/developer/operator shall be responsible to pay all sales, use, business and other applicable taxes, and all license, registration, and other fees and permits required under federal, state and local law and pursuant to the Development Agreement for the project."

Condition of approval no. 7 reads as follows:

"7. Secure any required permits from the City Building Department, Fire Department, Police Department, Sacramento County Air Quality Management District, and/or Sacramento County Health Department (as applicable) prior to building occupancy or operation including any required approvals under Condition No. 8 of Conditional Use Permit CUP 05-18."

Failure to pay required fees and complete fire and planning inspections constitute violations of the above conditions of approval and constitutes grounds for revocation of Conditional Use Permit 05-18.

Section 7.6 of Development Agreement 2018-02 states that, "If the Developer voluntarily surrenders the Conditional Use Permit, or if the Conditional Use Permit is revoked by the City, then Developer shall immediately cease operations at the Property and this Development Agreement shall terminate automatically, without further action required by either party."

If Planning Commission and City Council revoke Cup 05-18, DA 2018-02 will be terminated automatically. Staff is not recommending direct action on the development agreement at this time as further action is not required.

FISCAL IMPACT

There is no fiscal impact associated with this action.

RECOMMENDATION

Staff recommends that Planning Commission motion to revoke Conditional Use Permit CUP 05-18 and Recommend to City Council Revocation of CUP 05-18 for violation of conditions of approval no. 3 and 7 of CUP 05-18.

The City was awarded \$22,000 from the California Governor's Office of Business and Economic Development (GO-Biz) to start a **cannabis equity program**. The City will release a bid to find a consultant to complete the equity survey necessary to start the program. Once the program is implemented, the City will be able to receive funds to aide eligible cannabis operators or applicants.

Following presentation to Planning Commission and City Council last month, Consultants Dynamic Planning submitted the draft 2021-2029 Housing Element to the California Department of Housing and Community Development (HCD). Once reviewed and approved by HCD, a final version of the Housing Element will be brought back to for formal adoption by the City this fall.

Following its approval by City Council last month, Staff have submitted the proposed **Sphere of Influence** amendment to the Sacramento Local Agency Formation Commission (LAFCo). Staff will update Planning Commission and City Council as the application process progresses.

Staff attended the May 25th **Delta Conveyance Project Community Benefits Program** Workshop. Benefits programs are typically done in parallel to large infrastructure projects to fund projects not directly linked to the development for affected communities. The benefits program is in early stages of the development and the workshop was largely dedicated to taking suggestions for funding ideas from the larger delta community. A list of suggested ideas from the previous meetings is attached to this report. No indication was given of what specific ideas would be funded, or the amount of funding the State will be providing will be. The benefits program funding is contingent on the findings of the Delta Conveyance Project's environmental impact report, which is not being released until summer of 2022.
