## CITY OF ISLETON PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the City of Isleton City Council will hold a public hearing on Tuesday, September 13, 2022, at 6:30 p.m. at Isleton Community Center, 208 Jackson Blvd., to consider the following:

**General Plan Amendment GPA 2022-01;** Update to the City of Isleton Housing Element for the Planning Period of 2021 through 2029. The Housing Element is part of the City's General Plan, the State-mandated document that guides long-range growth and development decisions. The purpose of the Housing Element is to identify the City of Isleton's existing and projected housing needs for households of all income levels, ages, and those with special needs. The Housing Element Policy Document states the City's goals, policies, quantified objectives, financial resources, and scheduled programs for the preservation, improvement, and development of such housing. The housing element does not modify land uses, building heights, or densities or amends building codes. The policies provide a to guide future decisions on housing preservation, protection, and production and reflects the community's vision of equity and inclusion in housing related topics. During a noticed public hearing on August 9, 2022, the City of Isleton Planning Commission recommended approval of this project for adoption by the City Council.
