The City has began enforcing the commercial district standards. These standards include no residential use in the front of commercial buildings.

The City has approved the provision of a new internet service provider – unWired Broadband. This service will bring a significant improvement in internet service for the whole town. Service availability is anticipated for early 2024.

The City appointed two new public members, Paul Cantelli and Lori Kent to the Isleton Historical Review Board.

#### **CITY PROJECTS**

Wilson Park Rehabilitation is under construction and will be unavailable to the public for approximately three months. Improvements include new playground equipment, park lighting, BBQ grills, small and large dog parks and skate park.

#### WAIVER OF DEBT BY THE CITY OF ISLETON OWED BY ISLETON REDEVELOPMENT SUCCESSOR AGENCY, CITY OF ISLETON RESOLUTION 27-23

#### **SUMMARY**

Staff Report

The City's Redevelopment Successor Agency (RDA) carries an outstanding debt of \$1,366,205 to various local agencies, approximately a third of which is owed to the City of Isleton. Staff is recommending the City Council forgive the portion of RDA debt owed to the City.

#### DISCUSSION

The RDA is in debt to several other public agencies including the Sacramento County Office of Education, the Sacramento County Library, River Delta School District, and the Los Rios Community College District (see attachment B for complete list, this list provided by the Sacramento County Successor Agency Oversight Board). The City is seeking relief of this RDA debt with these agencies. Waiving the portion of debt owed to the City by the RDA sets a pattern of good faith to other agencies and can assist with debt relief from outside agencies. At this time, staff is requesting that the City Council, via resolution, waive any and all outstanding debt between the RDA and the City.

#### **Redevelopment Background**

Redevelopment began as an urban renewal and the financing function for affordable housing and urban redevelopment and was initiated in the State of California with the passage of the Community Redevelopment Act in 1945. Several changes to how RDAs can be financed over the pursuing decades led to their greater use and a larger scope of their project areas-most notably the allowance of 'tax-increment financing' and the State taking on greater responsibility for funding local school districts, freeing up local tax revenues to be redirected towards the RDAs

The widespread adoption of redevelopment agencies and their financing methods led to increased financial strain on the State as local tax funds as money were channeled away from funding education. Many redevelopment projects under performed while consuming large portions of tax revenue. A long period of fiscal abuses of this tax provision occurred for several decades throughout the State and also in the City of Isleton.

These practices became widespread leading to the state legislature passing ABX1 26 in 2011, which ended RDAs along with the scheduled repayment of their outstanding debts.

#### FISCAL IMPACT

The total amount of debt forgiveness recommended is \$453,593, which represents a 34% reduction of the \$1,366,205 debt obligation of the RDA. The remaining debt is listed in Attachment B to this report.

#### **RECOMMENDATION**

Staff recommends City Council vote to approve Resolution 27-23, Forgiving the Repayment of Any Loan, Advance, or Indebtedness Owed to the City of Isleton by the Redevelopment Successor Agency of the City of Isleton.

#### **RESOLUTION NO. 27-23**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ISLETON FORGIVING THE REPAYMENT OF ANY LOAN, ADVANCE, OR INDEBTEDNESS OWED TO THE CITY OF ISLETON BY THE REDEVELOPMENT SUCCESSOR AGENCY OF THE CITY OF ISLETON

WHEREAS, the City of Isleton is a municipal corporation and a general law city of the State of California ("City"); and

WHEREAS, the Redevelopment Successor Agency of the City of Isleton is an agency, corporate and politic, organized and existing under the California Community Development Commission Law (Health & Safety Code Section 34100) and the California Community Redevelopment Law (Health & Safety Code Section 33000 et seq.) as a Redevelopment Agency of the City of Isleton that functions without a housing authority and thus only as a redevelopment agency; and

WHEREAS, the California Community Redevelopment Law, pursuant to Section 33354.7 of the California Health and Safety Code, requires that the City Council (a public body) in order to forgive the debt of the Redevelopment Successor Agency, pass a resolution specifying: the name of the public body or agency, the amount of the proposed forgiveness, the terms of the loan, advance, or indebtedness, the fiscal effect of the proposed forgiveness on the public body, the fiscal effect of the proposed forgiveness on the agency or public body intends to act on the proposed forgiveness which shall be no less than 15 days after the adoption of the resolution; and

WHEREAS, the amount of indebtedness of the Redevelopment Successor Agency of the City of Isleton to the City of Isleton stands at \$453,593.00 and no terms as to the repayment were struck between the Agency and the City for this debt obligation; and

WHEREAS, the City has determined no adverse fiscal effects upon either the City or the Agency; and

NOW, THEREFORE, the City Council of the City of Isleton resolves as follows:

<u>SECTION 1</u>. The City of Isleton forgives the repayment of any loan, advance, or indebtedness that has been owed to the City of Isleton by the Redevelopment Successor Agency of the City of Isleton.

SECTION 2. The City shall act upon this forgiveness on or before December 27th, 2023

It is not that often that the IHPRB can enjoy an influx of personnel who wish to participate in the administrations of the board, so at this time, with the recent addition of two new members, Michelle's inclusion would be most timely. As the city prepares itself for Certified Local Government (CLG) status, the IHPRB will likely broaden its role, helping the city to develop proposals regarding the acquisition of grants. Michelle's abilities to conduct detailed research, and to put ideas to paper will make her a valuable asset during this time. As the IHPRB will continue to administer the Certificate Of Appropriateness (COA) process, it should be noted that Michelle is already somewhat familiar with this process having submitted a COA on behalf of 38 Main Street. This is a great opportunity to get the IHPRB up to full membership with qualified personnel, I look forward to welcoming Michele to the board at the behest of the City Council.

Monthly Code Enforcement Report

Date: December 2023

<u>1. Hazards to the Public:</u> The Code Enforcement Division continues its efforts to ensure the safety of the public. Enforcement activities focus on hazards present in public and private properties and address issues related to stranded and abandoned vehicles and equipment.

- Complaints regarding an ongoing and growing "homeless encampment" in the area of 6<sup>th</sup>/H Street.

- 28 Main Street violations, electrical, cracking/cracked walls, trash & debris, and ongoing RHIP violations are still not within compliance.

#### 2. Main Street and Commercial Frontages:

- The City is committed to maintaining the infrastructure and pedestrian facilities along Main Street. Additionally, efforts have been initiated to educate all business owners about their obligations under the Code to keep their commercial frontages presentable, regardless of whether the business is active. Numerous addresses along Main Street have blocked or covered storefronts/windows/doors, preventing passersby from seeing inside the address. These businesses do not appear open to the public and confirm they are active businesses.

- Several addresses have been identified and sent Notice of Violation letters regarding the Downtown/Main Street Business/Residential Ordinance

#### <u> 3. General Code Enforcement:</u>

The Code Enforcement Division actively monitors the city to identify properties and areas not complying with Municipal Code Section 10.16.020 on Nuisances. Various conditions have been observed, including abandoned or deteriorated buildings, litter and debris, adrift household goods, property maintenance issues, and abandoned vehicles.

- Open Investigations: The Code Enforcement Division has several ongoing investigations into potential Municipal Code Violations. In addition, letters of compliance have been sent to property owners in order to address any identified violations and bring the properties into compliance with the regulations. Administrative Citations and Fines are being issued for noncompliant properties.

#### - Rental Housing Inspections Program:

Numerous rental housing inspections have been performed. Several inspections had violations/issues located/found during the inspections; those were addressed, and reports were sent to the property owners to address/fix. Code Enforcement currently working numerous rental inspections or reinspections. Several non-compliant property owners do not meet the Rental Housing Inspection Program Municipal Code, and warning letters were sent to attempt compliance with the Municipal Code.

These monthly code enforcement efforts are aimed at safeguarding public safety, maintaining the attractiveness of Main Street, and ensuring compliance with the Municipal Code throughout the city.

Staff Report: Homeless Encampment Complaint - 6th Street and H Street

Date: December 12, 2023

Subject Property: APN# 15700400690000

Complaint Received: November 27, 2023

**Complainant: Numerous** 

#### Nature of Complaint:

Several complaints were filed regarding a "homeless person" setting up a camp, creating a mess, and having an "open flame" at the location of 6th Street and H Street, where an individual was observed BBQ'ing on private property. The complaint mentioned concerns about potential fire hazards and the presence of a blue SUV. Additionally, a resident called in to express worries about the safety of children walking in the vicinity due to past sightings of the subject engaging in inappropriate behavior in the encampment.

#### Actions Taken:

1. Initial Response:

Public Works, Fire Chief, and Code Enforcement promptly responded to the complaint on November 28, 2023, to assess the situation.

#### 2. Investigation:

Upon arrival, it was determined that the subject was BBQ'ing and eating in an open spot on private property, posing no immediate fire danger to surrounding vegetation. Per Cal. Code Regs. Tit. 14, § 918.5 - Lunch and Warming Fires, the subject BBQ'ing at the location was found not to be in violation of Cal. Code Regs. Tit. 14, § 918.5, as there was a sufficient clearance of 10 feet from the perimeter of the fire, and no immediate fire hazard was present. The subject was located on private property and was currently not showing an immediate threat or hazard to the public. Photos of the area were taken for documentation.

3. Communication with Complainant:

The City of Isleton is an equal opportunity provider and employer.

Code Enforcement communicated with the residents who made the complaints, assuring them that the violation process had been initiated. The residents were advised to contact the Sheriff's Office if there were immediate safety concerns with the subject.

#### 4. Notice of Violation:

A Notice of Violation letter was sent to the listed property owner on November 28, 2023, outlining the specific violation related to IMC 10.16.020 subsections E, F, G, and W(Nuisance).

Cal. Code Regs. Tit. 14, § 918.5 - Lunch and Warming Fires:

The subject BBQ'ing at the location was found not to be in violation of Cal. Code Regs. Tit. 14, § 918.5, as there was a sufficient clearance of 10 feet from the perimeter of the fire, and no immediate fire hazard was present.

#### Encounter with Subject:

Code Enforcement responded to the location and encountered a male named Gabe, who claimed to be living at the site. Gabe, who identified as handicapped, refused to comply with Code Enforcement directives and refused to clean the area. The subject walked away from the Code Enforcement.

#### Next Steps:

1. Continue monitoring the site for compliance with the Notice of Violation.

2. If non-compliance persists, consider further enforcement measures, including fines and legal action.

3. Collaborate with relevant agencies to address the larger issue of homelessness and potential safety concerns raised by residents.
