Public Safety:


- Several addresses/properties have been identified as being occupied in violation of several Health and safety violations (17920.3); Code Enforcement, Fire Department, and Building Department are working on contacting the occupants and property owner. They are investigating the building as unsafe to occupy and determining the process to post it as a "Red Tag" status until violations have been resolved and inspected.

General Code Enforcement:

- Several Municipal Code violations were identified, and NOV letters were sent to property owners.
- Code Enforcement continues to address the ongoing parking and vehicle code violations throughout the City.
- Code Enforcement has contacted several properties regarding work being performed without permits and outside Isleton Municipal Codes.

Community Service:

- CSO vehicle is now marked and identified as "Community Service" for the City of Isleton.





Rental Housing Inspection Program:

- Several new and prior inspections have been performed on residences throughout the City of Isleton.
- Certified letters have been sent to new rental properties informing the property owner of the City's Rental Housing Program and to schedule new inspections.

RESOLUTION NO. 02-24 OF THE CITY COUNCIL OF THE CITY OF ISLETON APPROVE RURAL COMMUNITIES ASSISTANCE CORP TO PROVIDE A NO-COST SEWER RATE STUDY UNDER THE ENVIRONMENTAL PROTECTION AGENCY (EPA) TREATMENT WORKS FUNDING PROGRAM

SUMMARY

Staff advertised a request for proposal (RFP) for the sewer rate study in January 2024. During this time Rural Communities Assistant Corp. (RCAC) contacted the City to provide services to update the City's sewer rate study at no charge. RCAC provides no-cost technical assistance to small, rural, and disadvantaged communities through a funding program called Environmental Protection Agency (EPA) Treatment Works. The City of Isleton was selected for RCAC to perform a sewer rate study under EPA Treatment Works because of its status as a disadvantaged community.

With the attorney's approval, the City will be able to accept the RCAC service and can decline the RFP's submitted bids.

Staff is requesting City Council's direction to proceed and approve Interim City Manager to sign the RCAC Environmental Department Community Work Plan and/or other documents needed for RCAC to complete an updated sewer rate study.

DISCUSSION

The last adjustment of City sewer rates was in 2012 per Resolution 2012-03 (attached). The estimated complete date of the RCAC sewer rate study is June 30, 2025. City would be able to propose a sewer rate increase in July 2025.

Over the past ten years the City's costs for labor, supplies, energy, and equipment for the Wastewater Treatment Plant (WWTP) have risen. The Bureau of Labor Statistics indicates that cost of over this time period are up 31.3%. Of note is the age and deterioration of the WWTP and its associated excessive repairs and operational costs. The Plant is of 1970s design and generates extra maintenance costs of in the range from \$50,000 to \$100,000 annually. (The City is currently undertaking a repair bill of \$40,000 for replacement of the intake grinder, repairs to the remote alarm system at a cost of over \$6,000, and repairs to the sewer pond roads of approximately \$12,000.)

The completed the planning study for the Isleton Wastewater Treatment System Improvement Project pursuant to a half million dollar grant from the California Water Board. This study assisted the City for a capital facility improvement project to the WWTP along with a multimillion dollar grant similarly funded by the State. As part of the improvement funding, the State will review the current financial operations of the Plant and may require a current rate study. The absence of the study for over a decade will be an unfavorable reflection on the Plant financials.

It is also noted that the City is operating the plant under a Water Quality Control Board Notice of Violation. The Board, as a practice, leaves NOVs in place without relief to ensure that agencies progress on studies and subsequent improvement projects to old and potentially hazardous sewer plants.

In the interest of addressing the higher sewer plant operations and expenses and in anticipation of State requirements for the Plant Upgrades, Staff recommends proceeding with issuing a request for proposals for a Study of the City of Isleton Sewer Rates.

FISCAL IMPACT

The administrative costs with this action is minimal and sewer rate study is fully funded by State funds and completed by the Rural Communities Assistance Corp. (RCAC).

RECOMMENDATION

It is recommended that the City Council adopt Resolution No. 02-24 of the City Council of the City of Isleton Approve Rural Communities Assistance Corp to Provide a No-Cost Sewer Rate Study Under the Environmental Protection Agency (EPA) Treatment Works Funding Program.

WHEREAS, said notice was provided in accordance with applicable law including Proposition 218;

WHEREAS, said hearing was duly held, and conducted at a regular City Council meeting on January 11, 2012, at a continued meeting on January 17, 2012 and at a continued; and at a continued meeting on February 15, 2012;

NOW, THEREFORE, the City Council of the City of Isleton does hereby find and resolve as follows:

Section 1: The City Council finds and declares that that written ballots (or letters) received by rate payers in opposition to an increase numbered less than five percent of the total number of sewer rate payers in response to sending individual hearing notices to each rate payers as required by Proposition 218.

Section 2: The City Council hereby approves raising the Isleton sewer rates to the following amounts:

Single-Family (outside)	\$79.00
Multi-family (in city)	\$58.00
Multi-family (outside)	\$64.00
Commercial (in city)	\$72.00 x multiplier
Commercial (in city)	\$79.00 x multiplier.

This resolution shall supersede all prior resolutions and ordinances concerning sewer rates to the extent it is inconsistent therewith.
