#### **Summary:**

The Delta Region Geologic Hazard Abatement District (GHAD) and EPIC Insurance Brokers & Consultants (EPIC) seek to collaborate on the development of a community-based financial and resiliency flood insurance solution. This partnership aims to address the flood risks faced by the GHAD with a solution scheduled to be implemented by January 1, 2025, or earlier. The GHAD will also pursue funding from the California Department of Water Resources to support the solution's development.

The proposed MOU outlines the roles and responsibilities of both parties. EPIC will assist in identifying underwriters and insurance intermediaries, obtaining insurance quotes, and developing parametric flood claims solutions. GHAD will name EPIC as its Broker of Record and authorize them to proceed with obtaining quotes and securing the necessary coverage.

The GHAD Board is asked to approve the MOU and authorize the Board Chair to execute it on behalf of the district.

#### Recommended Action:

- 1. Approve the Memorandum of Understanding (MOU) with EPIC Insurance Brokers & Consultants
- 2. Authorize the Chair, Iva Walton, to execute the MOU on behalf of the Delta Region GHAD.

#### Background:

The GHAD and EPIC propose to collaborate on a flood insurance solution to mitigate risks within the district. The MOU includes the following key elements:

- Development of the insurance solution with a target date of January 1, 2025.
- Securing funds from the California Department of Water Resources totaling \$200,000 over two years.
- EPIC's efforts to identify third-party providers and administer parametric flood claims solutions.

#### Fiscal Impact:

Potential financial support from the California Department of Water Resources in the amount of \$200,000, split between 2024 and 2025. The proposed collaboration may result in future costs associated with the supplemental property tax assessments needed for ongoing funding in subsequent years.

EPIC Insurance Brokers & Consultants (EPIC) and the Delta Region Geologic Hazard Abatement District (GHAD) wish to collaborate on the following activities:

- Develop a community-based financial and resiliency flood insurance solution offering
  protection for the GHAD's risks with an inception date of January 1, 2025, or earlier
  (referenced herein as the Solution).
- Secure funds from the California Department of Water Resources (seeking \$200,000 in the aggregate, with 50% or \$100,000 allocated for 2024 and 50% or \$100,000 allocated for 2025) to fund the Solution.

In connection with this collaboration, EPIC intends to:

- Identify third-parties including, for example, underwriters, insurance intermediaries, and/or third-party administrators, to assist in developing the Solution, including, as appropriate, those parties necessary for securing quotes, binding coverages, securing related parametric trigger solutions (e.g., FloodFlash) as well as administering the parametric flood claims with the GHAD.
- Seek to secure an insurance quote for the Solution to be presented by EPIC to the GHAD Board on or about October 1, 2024.
- Subject to the agreement of the GHAD Board and GHAD otherwise satisfying all requirements of the applicable underwriter(s) to bind, provide insurance brokerage services to bind the Solution.
- Colloborate with GHAD to develop enhancements to the Solution for year two and beyond that may include partial grant funding and the balance paid for by the constituents of the GHAD.
- In the event EPIC places the Solution, EPIC intends to receive compensation in connection therewith, which may include commissions payable by insurance carriers that underwrite the Solution.

In connection with this collaboration, GHAD intends to:

- Name EPIC as its Broker of Record, execute a formal Broker of Record with EPIC, and take those other action necessary authorize EPIC to seek the Solution and obtain quotes as contemplated herein.
- Adopt the Solution presented by EPIC where GHAD determines such Solution meets its requirements or provide direction to EPIC on where this Solution fails to meet its requirements.
- Secure funds from the California Department of Water Resources (seeking \$200,000 in the aggregate, with 50% or \$100,000 allocated for 2024 and 50% or \$100,000 allocated for 2025) to fund the Solution.
- Prepare a ballot initiative to secure local funding through a supplemental property tax assessment (e.g., Proposition 218) for year two and beyond.

Each of GHAD and EPIC agree to keep confidential all information exchanged between the parties in connection with this subject matter and agree not to disclose such information to any third party without the prior written consent of both of us, provided that EPIC is expressly permitted to disclose GHAD information to third parties as may be necessary in order for EPIC

to seek to secure the Solution (including, for example, disclosure of GHAD information to insurance carriers).

This is intended to simply outline the general terms of a proposed business relationship and is not intended to create any legally binding obligations on the part of any party. The parties understand that EPIC makes no guarantee that a Solution will actually be secured and the GHAD has no obligation to accept the Solution.

Each of GHAD and EPIC agree to use best efforts to negotiate and mutually agree on a definitive agreement that will set forth the terms and conditions of our business relationship.

# Proposed Resolution 24-03 Intergovernmental Contract between Delta Region GHAD and the Department of Water Resources

**SUBJECT:** Intergovernmental Contract between Delta Region GHAD and the Department of Water Resources

#### SUMMARY

The Department of Water Resources (DWR) has proposed to provide the Delta Region GHAD with \$100,000 in funding through an intergovernmental contract. The funds will be used to purchase a one-year parametric insurance policy as a pilot program to provide flood recovery payments in the event of a levee failure within the GHAD's jurisdiction. This pilot will help document the process and feasibility of implementing parametric insurance as a risk mitigation tool for flood-prone areas.

#### RECOMMENDATION

The Board is recommended to accept the \$100,000 grant from the Department of Water Resources (DWR) to fund the purchase of a parametric insurance policy as part of a pilot program for flood recovery in the Delta Region GHAD. The policy is to provide funding for the flood recovery program for one year.

#### **BACKGROUND**

The Delta Region GHAD is the first of its kind to pilot a community-wide parametric flood recovery program, which has the potential to be expanded to other underserved communities in the Central Valley. The program is designed to offer fast, predictable payouts to residents affected by levee failures and other flood events, based on pre-set flood triggers.

The funding from DWR will enable the GHAD to purchase a 1-year parametric insurance policy and will help DWR evaluate the process of policy implementation, including:

- Identifying the properties that will benefit from the insurance policy.
- Establishing a governance framework for the administration of policy payouts.
- Securing the services of a qualified insurance broker to negotiate the policy.

#### **OBJECTIVES OF THE CONTRACT**

The DWR contract outlines several key objectives for the GHAD to address during the pilot program:

- 1. **Insurance Policy Procurement**: GHAD will obtain a parametric insurance policy to cover losses associated with a flood event (stormwater and riverine) for one year.
- 2. **Documentation and Reporting**: GHAD will provide documentation on the process of implementing parametric insurance, including challenges, opportunities, and recommendations for long-term program expansion.
- 3. Governance and Risk Management: GHAD will establish governance structures and frameworks for managing the insurance policy and any funds that are disbursed following a loss event.

#### PROPOSED ACTION

The following actions are proposed to implement the intergovernmental contract with DWR:

- 1. Accept the \$100,000 agreement provided by DWR for the purchase of a parametric insurance policy.
- 2. Authorize the GHAD Manager to engage EPIC Insurance Brokers to negotiate the parametric insurance policy called for in the DWR agreement, with a target date for policy approval at the November Board meeting.
- 3. Direct the GHAD Manager to document the process of securing the policy and provide a report to the Board, covering procurement challenges, market analysis, and recommendations for long-term sustainability, including the potential for a Proposition 218 vote.

#### **FINANCIAL IMPLICATIONS**

The \$100,000 grant from DWR will fully fund the purchase of the parametric insurance policy for one year. The GHAD Manager will work with EPIC Brokers to ensure that all necessary procurement steps are taken within the budget. All expenses related to the implementation of this activity are to be covered by DWR funding.

## **NEXT STEPS**

- Upon approval, staff will engage with EPIC Brokers to initiate the process of securing a parametric insurance policy.
- A report on the procurement process and an insurance policy will be presented to the GHAD Board at the November 2024 meeting for reivew and approval.

DELTA REGION GEOLOGIC HAZARD ABATEMENT DISTRICT RESOLUTION NO. 24-03

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE DELTA REGION GEOLOGIC HAZARD ABATEMENT DISTRICT (GHAD) AUTHORIZING THE ACCEPTANCE OF A \$100,000 GRANT FROM THE DEPARTMENT OF WATER RESOURCES (DWR) AND THE ENGAGEMENT OF EPIC INSURANCE BROKERS TO SECURE A PARAMETRIC INSURANCE POLICY

WHEREAS, the Delta Region Geologic Hazard Abatement District (GHAD) was formed to manage and mitigate the risks associated with geologic and flood-related hazards within its jurisdiction, particularly flood risk from levee failures; and

WHEREAS, the Department of Water Resources (DWR) has proposed an intergovernmental contract to provide the Delta Region GHAD with \$100,000 in grant funding to purchase a parametric insurance policy as part of a pilot program aimed at providing recovery payments to property owners within the Delta Region GHAD in the event of a levee failure; and

WHEREAS, parametric insurance is a financial tool that provides predetermined payouts based on pre-defined triggers, such as flood events or levee breaches, and can offer a rapid and reliable method for distributing recovery funds to affected communities; and

WHEREAS, the Delta Region GHAD intends to utilize the services of EPIC Insurance Brokers to negotiate and secure the parametric insurance policy and to assist in documenting the implementation of the pilot program; and

WHEREAS, the pilot program will help evaluate the viability and sustainability of parametric insurance as a risk mitigation tool for the Delta Region GHAD, and the program's success may lead to further expansion to other underserved flood-prone communities in the Central Valley;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Delta Region Geologic Hazard Abatement District as follows:

- 1. Acceptance of Grant Funding: The Board of Directors hereby authorizes the Delta Region GHAD to accept the \$100,000 grant from the Department of Water Resources to fund the purchase of a parametric insurance policy.
- 2. Engagement of EPIC Insurance Brokers: The Board of Directors hereby authorizes the GHAD Manager to engage EPIC Insurance Brokers to negotiate and secure the parametric insurance policy and assist in documenting the procurement process, with the finalized insurance policy to be presented for Board approval at the November 2024 Board meeting.
- 3. **Documentation and Reporting**: The Board of Directors directs the GHAD Manager to prepare a report documenting the procurement process, challenges encountered, policy structure, and recommendations for long-term sustainability, including a potential Proposition 218 vote for future funding.
- 4. Authorization of Actions: The Board of Directors authorizes the GHAD Manager to take all actions necessary to implement this resolution, including but not limited to signing documents and entering into agreements in furtherance of this resolution.
